#### 4. FIRST AID MEASURES

Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated.
<b>Advice on safe handling:</b>	Avoid contact with skin, eyes and clothing. A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.
