### 4. FIRST AID MEASURES

<b>Inhalation:</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.

### 5. FIRE-FIGHTING MEASURES

<b>Precautions for firefighters:</b>	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so.

### 6. ACCIDENTAL RELEASE MEASURES

<b>Personal precautions, protective equipment and emergency procedures:</b>	Use extra personal protective equipment (self-contained breathing apparatus). Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
<b>Environmental precautions:</b>	Prevent product from entering drains.
<b>Methods and materials for containment and cleaning up:</b>	Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
<b>Prevention of secondary hazards:</b>	Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

## 7. HANDLING AND STORAGE

### Precautions for safe handling

**Technical measures:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling.  
Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated.

**Advice on safe handling:** Avoid contact with skin, eyes and clothing.  
Confirm in advance if peroxides exist when operations involving heating such as distillation are carried out.
